Read:- Minutes of the 137<sup>th</sup> meeting of the Academic Council held on 31.12.2022.

### ORDER

A proposal for granting relaxation to the on campus residential period of PhD degree for in-service candidates from ICAR institutions/National institutes/other SAUs by allowing them to rejoin their parent institutes after one year of course work at KAU and conduct thesis work at the institutes for the remaining two year residential period subject to the satisfactory completion of certain conditions was placed before the 137<sup>th</sup> meeting of the Academic Council held on 31.12.2021.

The Academic Council has approved the above proposal.

In consonance with the decision of the Academic Council, the following orders are issued.

In-service Ph.D candidates from ICAR institutions/National institutes/ other SAUs are allowed to rejoin their parent institutes after one year of course work at KAU and conduct thesis work at the institutes for the remaining two year residential period subject to the satisfactory completion of the following conditions.

1. The institute shall enter an MoU with KAU for facilitating PG Research and Education.
2. The MoU should include clauses that protect the rights of KAU for the intellectual property and publications generated out of the research.
3. There should be competent scientists to co-guide the candidate at the parent institute. Research work should be related to the mandate of the institute and the institute should provide adequate facilities.
4. The co-guide shall monitor the progress of research work and send report to the Head of the Department at KAU at the end of each semester.
5. The Chairman should report the progress of work to the Head of Department at KAU at the end of each semester.
6. The student should complete formalities regarding semester registration, including payment of fees within the stipulated time.
7. There should be no financial commitment to KAU. The expense for research work will be met by the sponsoring institute or by the candidate.
8. Research evaluation and defense seminar should be conducted at the concerned department in KAU, where the students has registered for the course.
9. The student should submit the thesis at KAU and complete all other formalities for obtaining degree.

10. All other rules and regulations of KAU have to be strictly adhered to.
11. The student should not indulge in any unlawful activities and should abide by the rules of both the institutions.

Clause 18 (a) of Regulations for Post Graduate Programmes, 2013 is amended to the above extent.
